### **302.00 Apparatus Driver Responsibilities**

**302.01 - PURPOSE:** To provide uniform requirements for apparatus driver training and requalification.

**302.02 - PROCEDURE:**

1. Possess a valid Montana State Drivers License and be at least 18 years of age.
2. Be off fire department probation.
3. Submit a written request to and approved by the fire chief to start driver training.
4. Receive permission to start training by the fire chief and after initial approval any chief officer can give permission. This permission will be given only after investigation into the driver's record and capability.
5. The trainee's driving of emergency vehicles shall be limited to training and non-emergency activities. **ONLY EXCEPTION:** If an emergency situation occurs and there is not a certified operator present at that time and the trainee has been trained and tested successfully on that apparatus and approved by the officer in charge to act in this capacity. The trainee may operate the vehicle during that emergency provided the officer in charge or trainee contacts LCFC by radio and requests that the tones and siren be activated requesting a driver. If no driver should show up at the station within a reasonable amount of time, the trainee may drive the apparatus.
6. Training sequence for the apparatus will be determined by the chief and the candidate's residence location.

7. Complete a minimum of ten hours of training on that vehicle which is requested, this includes (10) formal road exercises of 45 minutes in duration with the truck officer.
8. Pass a final road test given by 3 chief officers prior to advancing to the next truck.
9. Maintain and exhibit a commendable driving record, reporting all infractions, accidents, suspensions or revocations to the Fire Chief.
10. Qualified drivers may be required to requalify on each type of apparatus semi-annually; and completing the Polson Fire Department Emergency Driving Course every other year.
11. Requalification shall consist of successfully completing a driver qualification test given by a chief officer.
12. Requalification tests may be waived by the Fire Chief based on observations of the drivers at alarms and/or drills.
13. The right to drive apparatus may be revoked by the Fire Chief at anytime.
14. The record keeping of the training will be done on Polson Fire Department Apparatus Operator Qualification Report. This is the only means to document the type of training and length of training.

**302.03 - DUTIES OF DRIVER/PUMP OPERATOR:**

1. To insure the safe and rapid arrival of the apparatus to the emergency scene.
2. To operate the fire pump.
3. Responsible for the return of all equipment to apparatus following all alarms.
4. Must be able to operate the radio.
5. Should have full knowledge of equipment on the apparatus.
